



Disclaimer for Events of the Camel Trophy History Club Germany

1. The undersigned releases the Camel Trophy History Club Germany (CTHC-G), as well as its representatives and agents, from any liability for damages incurred in connection with this event. In particular, entering and using the event grounds is at the undersigned's own risk.
2. The undersigned releases the CTHC-G, as well as its representatives and agents, from any liability towards persons whom the undersigned has brought to the event grounds or who are present on the event grounds at the undersigned's instigation.
3. This disclaimer of liability does not include the exclusion or limitation of liability for damages resulting from injury to life, body, or health caused by a negligent breach of duty by CTHC-G, or by an intentional or negligent breach of duty by a legal representative or agent of CTHC-G. Furthermore, this disclaimer of liability does not include the exclusion or limitation of CTHC-G's liability for other damages caused by a grossly negligent breach of duty by CTHC-G, or by an intentional or grossly negligent breach of duty by a legal representative or agent of CTHC-G (§309 German Civil Code).
4. The undersigned acknowledges the terms of use/conditions of the owner/operator and will follow the instructions of the organizer/operator. He also guarantees this for the group of persons mentioned under point 2.
5. If the undersigned brings a vehicle onto the event grounds, they must ensure that it complies with the German Road Traffic Licensing Regulations (StVZO), in particular that it is registered and insured against liability, and is driven only by persons who possess the required valid driver's license.
6. The German Road Traffic Regulations (StVO) apply on the event grounds; however, pedestrians have priority.

Violation of rules 4 and 5 may result in exclusion from the event.

This does not affect the organizer's right to control access to the premises.

Should any of these rules be deemed invalid, the validity of the remaining rules shall remain unaffected.

For liability reasons, non-members or unregistered participants are generally not permitted to drive on off-road terrain. Exceptions to this rule must be agreed upon with the board.

Driving off-road in rough terrain involves particular dangers for the vehicle, its occupants and third parties.

Driving in particularly challenging terrain, on steep slopes, in water-filled depressions, and towing and recovering vehicles using winches poses significant risks to the vehicle, its occupants, and bystanders!

If, as part of the above-mentioned event, the organizer (CTHC-G) or its agents require participants to drive through specific off-road sections during a trial, for driver training, or to assess their skills, driving through these sections can lead to vehicle damage, especially from contact with the ground, vegetation, or structures.

Loss of control due to traction loss also poses a risk of accidents and damage!

Privacy Policy based on REGULATION (EU) 2016/679 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation)

The processing of personal data from registrations for the annual meeting serves solely for processing contact requests and planning the event. In the case of contact via email, the necessary legitimate interest in processing the data also exists.

The other personal data processed during the registration process serves to prevent misuse of the registration form and to ensure the security of our events and IT systems.

STORAGE PERIOD

The data will be deleted as soon as it is no longer needed for the purpose for which it was collected. For personal data from registration forms and data transmitted by email, this is the case when the respective conversation with the user has ended. A conversation is considered ended when it is clear from the circumstances that the matter in question has been resolved and the data subject is no longer interested in receiving further information (e.g., information about future meetings and events) from CTHC-G.

The additional personal data collected during the submission process will be deleted no later than seven days after submission.

RIGHT TO OBJECT AND ERASURE

Users have the right to withdraw their consent to the processing of their personal data at any time. If a user contacts us by email, they can object to the storage of their personal data at any time. In such a case, the conversation cannot be continued. The objection should be sent to our address.

All personal data stored in connection with the contact will be deleted in this case.

CTHC-G events take place in publicly accessible spaces; there are no access restrictions or entry controls.

Therefore, at CTHC-G events, it is possible that both members and non-members may actively or passively receive data.

This may include: the function (position) of members within the association, their name and address, data on vehicles brought to the event and their owners, photos, audiovisual recordings, and reports of current or past CTHC-G events, e.g., from the press or notices.

Reports about CTHC-G events are frequently written and published. These reports may contain the data mentioned above. The reports and the data used are not checked for accuracy or completeness.

For the reasons stated above, CTHC-G cannot prevent or monitor any of this.

Consent to the publication of photos & videos under copyright law
